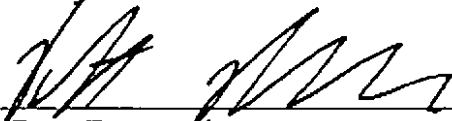
1. The name of the Corporation is Milam Howard Nicandri Gillam & Renner, P.A.
2. Amendments Adopted: Article I of the Articles of Incorporation of Milam Howard Nicandri Gillam & Renner, P.A. is hereby amended to read as follows:

**Article I
Name and Duration**
