**AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF
XVERUM, LLC,
A FLORIDA LIMITED LIABILITY COMPANY**

Pursuant to the provisions of section Chapter 605 of the Florida Revised Limited Liability Company Act, Xverum, LLC, adopts the following amendment and restatement to its Articles of Organization, which were originally filed on June 1, 2020 and assigned Document Number L20000148914:

ARTICLE I

NAME

The name of the Limited Liability Company is Xverum LLC (the "Limited Liability Company").

ARTICLE II
