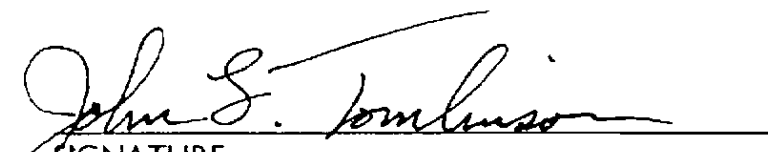

ARTICLE VI - PURPOSE

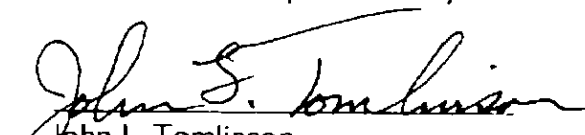
This Limited Liability Company is organized for the purpose of transacting any lawful business.
