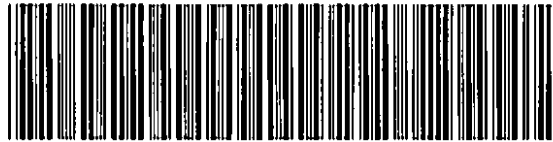

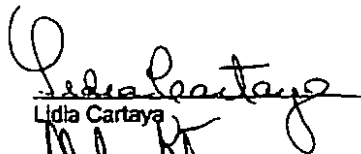
1. Name. The name of this limited liability company is **NORTH BAY FINANCE & INVESTMENT, LLC**

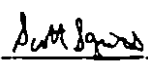
