**ARTICLES OF ORGANIZATION

The undersigned, Karmen Nenahlo, a natural person competent to contract and an authorized representative of 2908 DESTIN, LLC hereby presents these Articles of Organization as the Articles of Organization of 2908 DESTIN, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is 2908 DESTIN, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - MAILING & PRINCIPAL OFFICE ADDRESS


