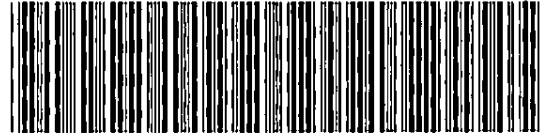

**PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**



OTHER PROVISIONS


