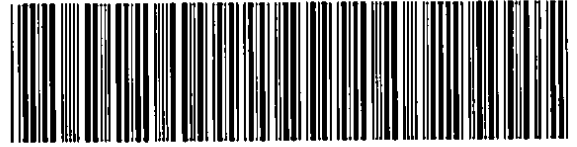

# ARTICLES OF INCORPORATION OF

## ANCIENT LEARNING OF THE MYSTICAL AND METAPHYSICAL ARTS, INC

The undersigned, by these Articles associate themselves for the purpose of forming a not-for-profit corporation under Chapter 617, Florida Statutes and certify as follows:

### ARTICLE I. NAME

The name of this corporation is:

ANCIENT LEARNING OF THE MYSTICAL AND METAPHYSICAL ARTS, INC.

### ARTICLE II. ADDRESS

### ARTICLE III. PURPOSES

The Corporation is organized exclusively for charitable, educational and scientific purposes, including for such purposes the making of distributions to organization that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended or the corresponding section of any future federal tax code (the "Code"). The Corporation is a not-for-profit public benefit corporation and is not organized for the private gain of any person.

The specific purpose of this Corporation is primarily to educate, inspire and help humanity achieve a better quality of life through the study of ancient mystical and metaphysical arts and to carry on other charitable activities associated with this purpose, as allowed by law.

C. Notwithstanding any other provision of this document, this Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding section of any future federal tax code ("Code") or by an organization contributions to which are deductible under Section 170(c)(2) of the Code.

#### ARTICLE VIII. DEDICATION FOR CHARITABLE PURPOSES

The property of this Corporation is irrevocably dedicated to charitable purposes, and no other part of the net earnings or assets of this Corporation shall ever inure to the benefit of, or be distributable to members, trustees, officers, director, or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of purposes set forth in the purpose clause hereof

Upon the winding up and dissolution of this Corporation and after paying or adequately providing for the debts and obligations of this Corporation, the remaining assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) or shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and that has established its tax-exempt status under Section 501(c)(3) of the Code. Any such assets not so disposed of shall be disposed of by the court having jurisdiction over the Corporation, exclusively for such purpose or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE VI. EXISTENCE AND DURATION

Existence of this corporation shall commence with the filing of these Articles of Incorporation with the Secretary of the State of Florida. This corporation shall exist in perpetuity.

#### ARTICLE VII. PROHIBITED ACTIVITIES

Notwithstanding any other provision of these Articles, Bylaws or by the laws of the State of Florida, the following limitations shall apply

A. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of purposes set forth in the purpose clause hereof.

B. No substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and this Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

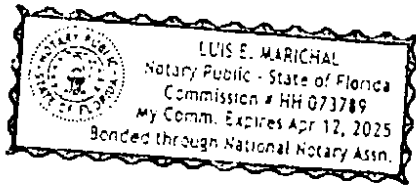

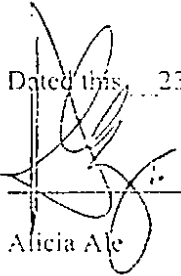
