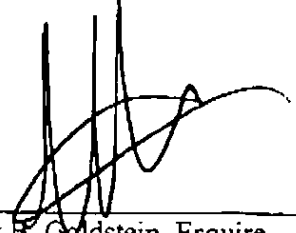
ARTICLE V
