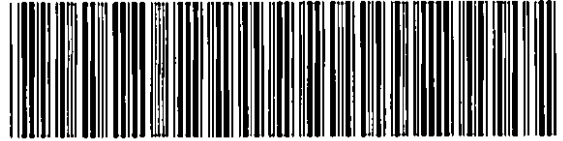

ARTICLE IV. MANAGEMENT

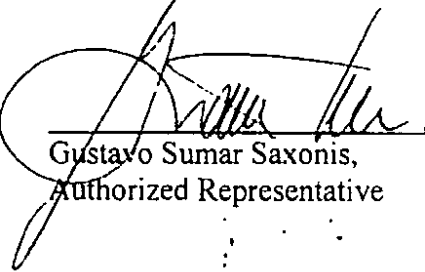
