# ARTICLE V - Perpetual Duration

The period of duration of AC & WDR CONSTRUCTION, LLC is perpetual.

### ARTICLE VI - Form of Management

The management of AC & WDR CONSTRUCTION, LLC shall be vested on the members pursuant to the Operating Agreement.

## ARTICLE VII - Purpose

The purpose of the company is to engage in any lawful or activity for which an LLC may be organized under the laws of Florida and the United States.

### ARTICLE VIII - Indemnification
