**ARTICLES OF ORGANIZATION  
OF  
323 ENTERPRISES, LLC**

1. Name. The name of this limited liability company is 323 ENTERPRISES, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Duration. The Company's existence shall be perpetual.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 1009 Gilmore Avenue, Nashville, Tennessee 37204.

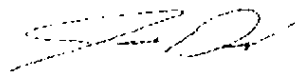

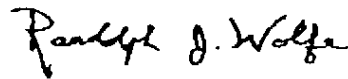
