AMENDMENT TO ARTICLES OF INCORPORATION OF ESPLANADE AT STARKEY RANCH NEIGHBORHOOD ASSOCIATION, INC.

(A Florida corporation not for profit)

Pursuant to Chapter 617.1006 of the Florida Not For Profit Corporation Act

ANDREW ("DREW") MILLER, Secretary of ESPLANADE AT STARKEY RANCH NEIGHBORHOOD ASSOCIATION, INC., a Florida corporation not for profit ("Association"), does hereby certify under the seal of the Association as follows:

- 1. The Association was originally incorporated on July 22, 2015, Document Number N15000007058, under Chapter 617 of the laws of the State of Florida.
- 2. The Declaration of Covenants, Conditions, Restrictions and Easements for Esplanade at Starkey Ranch was recorded on January 7, 2015, in Official Records Book 9132, Page 2522, et. seq., of the Public Records of Pasco County, Florida.
- 3. Article XIII, Section B, of the Articles provides that after the First Conveyance and prior to the Turnover Date the Articles may be amended solely by a majority vote of the Board, without the prior written consent of the Members, at a duly called meeting of the Board.
- 4. The Board of Directors of the Association is desirous of amending the Articles to change the number of directors to be elected at the Initial Election Meeting.
- 5. The following Amendment was adopted by the Board of Directors by Written Consent in Lieu of Meeting on June 28, 2022, and there are no members entitled to vote on the Amendment.

NOW, THEREFORE, the Articles are hereby amended as follows:

- 1. Article X, Section A, is hereby amended to read as follows:
 - A. The number of Directors on the first Board of Directors of the Neighborhood Association ("First Board") shall be no less than three (3) and no more than five (5) as determined by Declarant. The number of Directors elected by the Members subsequent to the "Declarant's Resignation Event" at the "Initial Election Meeting" (as hereinafter defined) shall be five (5) an odd number of no less than three (3) nor more than seven (7), as the Board shall from time to time determine prior to each meeting at which Directors are to be elected. Except for Declarant-appointed Directors, Directors must be Members or the parents, children or spouses or shareholders, members, officers or directors of Members. There shall be only one (1) vote for each Director.
