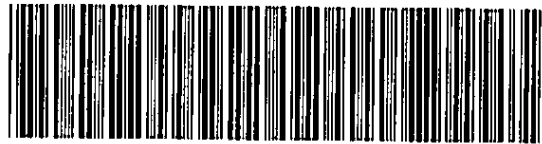

As per our phone conversation on May 2, 2022, it is important to recap all the events related to the Dissolution of Corporation for The Best Quality Corp. P04000162612.

Please be advised that upon trying to file the annual report for my corporation on April 30, 2022, I discovered that my company had been dissolved on January 26, 2022. I never received any notification of this dissolution. I was unaware that the company had been dissolved in addition I did not authorize this dissolution nor request for anyone to do so on my behalf. On March 6, 2022, I received an email advising that "the records of the Department of State show that your 2022 annual report has not been filed as of February 25, 2022." How can I receive this email if the company had already been dissolved?

As per the advice of the Department of State please find attached the Revocation of Dissolution form which is the only way I have now to recover the corporation, please let me know when this is resolve so we can file the annual report for 2022, which we were going to process on April 30, 2022,

I am also authorizing my wife Xinia Gayoso to be the point of contact for this matter, her cell phone number is 305-905-7617 and my cell phone number is 305-562-5912.

This is very concerning, I realized that anyone could make any changes to a corporation without any prior authorization and in addition to that, there is no email notification advising of the changes to alert of such actions. Furthermore, I just learned that after 120 days of a company being dissolved there is no way to recover the corporation and not only that the name will be freed and put available to anyone to use. Please consider making it more secure since this could be detrimental to any corporation.
