Re: Fraudulent and Illegal Change in Filing Statuses

Dear Mr. Secretary:

This firm is counsel to Mr. Orlando Llanes. As you may know, Mr. Llanes serves as Manager of various Florida companies including Fides Investments Group, LLC (FEI/EIN: 46-0848978) and Carrier Services of America, LLC (FEI/EIN: 46-1745274). This letter serves to advise you that an Amended Annual Report for each of the aforementioned companies was fraudulently and illegally filed without authorization by Mr. Llanes.

On June 6, 2022, Mr. Llanes received two emails from the Florida Department of State Division of Corporations notifying him that there were changes to the filing statuses of the two aforementioned companies. Mr. Llanes, having not recently filed or changed any records with the Division of Corporations, reviewed the 2022 Florida Limited Liability Company Amended Annual Report for each of the two companies and discovered that his signature was fraudulently used to sign as an authorized person. The annual reports were amended to remove Mr. Rigoberto Diaz as Manager from each of the two companies. The electronic signature of Mr. Theodore Miloch II, Esq., Registered Agent for each of the two companies, was also added fraudulently and illegally.

Pursuant to section 817.155, Florida Statutes (2021), a person may not "knowingly and willfully falsify or conceal a material fact, make any false, fictitious, or fraudulent statement or representation, or make or use any false document, knowing the same to contain any false, fictitious, or fraudulent statement or entry" within the jurisdiction of the Department of State. Presently, Mr. Diaz fraudulently and illegally signed electronically for both Mr. Llanes and Mr. Miloch, authorizing the removal of Mr. Diaz as Manager of the companies. To be clear, Mr. Llanes **did not sign** either of the Amended Annual Reports for Fides Investments Group, LLC or Carrier Services of America, LLC.

Enclosed you will find the two emails from the Florida Department of State Division of Corporations notifying Mr. Llanes of the changes, a photograph of the case report filed by Mr. Llanes with the Miami Dade Police (Case # PD220606183481), and copies of the two 2022 Florida Limited Liability Company Amended Annual Reports.

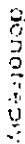
