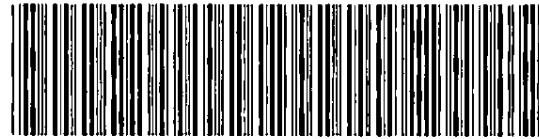

Under a previous filing stamped as filed September 22, 2022, TPT Global Tech, Inc. amended Article Fourth of its Articles of Incorporation as follows:

Each share of issued and outstanding Common Stock as of September 29, 2022, is reverse split on a one-for-one thousand basis on September 30, 2022, at 4 PM EDT, such that each old share represents 1/1000 of a new share. A surrender of the old share certificate is not required to be made by each shareholder, and the stockholder records will be automatically adjusted to reflect the reverse split. Fractional Shares shall be rounded up to the next whole share at the beneficial owner level. (The effective dates may be amended and extended by Board action in the event of delays in approval by FINRA.)

This action was withdrawn by the Board of Directors and a Majority of the Shareholders on September 27, 2022.
