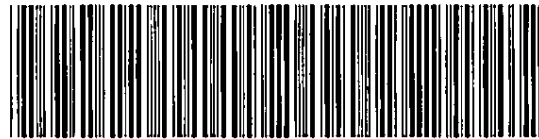

**FIRST:** That the First Article of the Certificate of Incorporation of the Corporation is hereby amended in its entirety to read as follows (the "Amendment"):

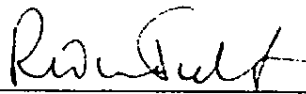

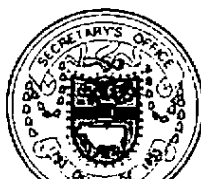
