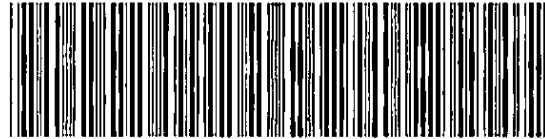

**ARTICLES OF INCORPORATION
OF
COMUNIDAD JUDIA INTERNACIONAL, CORP**

In compliance with Chapter 617, F.S., (Not for Profit), the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be COMUNIDAD JUDIA INTERNACIONAL, CORP (the "Corporation").

ARTICLE II: INITIAL PRINCIPAL OFFICE

The street and mailing address of the initial principal office of the Corporation is c/o RPA Law, 1000 Brickell Ave., Suite 1100, Miami, FL 33131.

ARTICLE III: PURPOSE

The Corporation is organized to:

- a) gather the ideas of Jewish people living in the United States and communicate them to other entities and organization with the purpose of promoting and improving the relationship between the Jewish people and others;
- b) safeguard the good name, the correct image and the prestige of Judaism;
- c) support, as much as possible, the Universal Declaration of Human Rights of the United Nations Organization, and to adhere to the postures of such organization and Declaration;
- d) foster the remembrance and study of the Shoah to ensure its conveyance to future generations;
- e) promote Judaism and its values;
- f) legally combat the expressions and conducts of hatred, the violence and persecution of groups, association of persons, communities, and any part of the population, based on race, nationality, religion, ethnicity, family situation, sex, sexual orientation, illness or disability, and social or economic condition;
- g) cooperate with the integration of people into society;
- h) promote inter-religious dialogue;
- i) promote the Sephardic Jewish ties and relations with Spain and its authorities;
- j) promote the Sephardic Jewish and Ashkenazi Jewish culture to preserve the customs, dialects, languages and other cultural elements that form an integral and indivisible part of the origin and history of the Jewish people;
- k) promote relations with all Jewish institutions in the United States and around the world;
- l) promote equal opportunities among people;

- m) promote the relations of the COMUNIDAD JUDIA INTERNACIONAL, CORP with different national institutions and sectors:
- n) support groups that promote Jewish activities to try to attain the maximum benefits for the community, without interfering in the internal autonomy of the organizational groups:
- o) address and raise awareness all forms of antisemitism and discrimination against jews:
- q) educate and inform people about Judaism and its values.

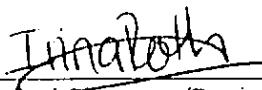

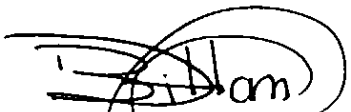
