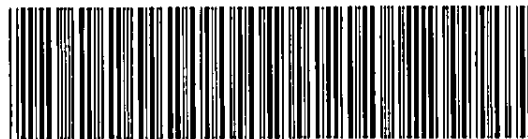



ARTICLES OF INCORPORATION

OF

SHADES IN PLACE, INC.

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the Corporation is **Shades IN Place, Inc.** RM

ARTICLE II

DURATION

The term of existence of the Corporation is perpetual. RM


