**ARTICLES OF ORGANIZATION  
FOR RESULTING FLORIDA LIMITED LIABILITY COMPANY

## ARTICLE VII - TERMINATION OF EXISTENCE

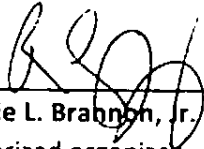
