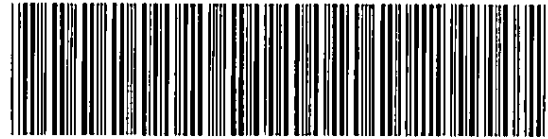



The Limited Liability Company is organized for the exclusive purpose of acting as a family trust company as described under s. 662.10, et seq. of Title XXXVIII, Chapter 662, F.S., the Florida Family Trust Company Act (the “FFTC Act”), and doing all things and exercising all powers and performing all functions which a family trust company is authorized or empowered to do, exercise or perform under or by virtue of the laws of the State of Florida, or which it may be by law hereafter authorized to do, exercise or perform; except that the Limited Liability Company shall be prohibited from engaging in any activity that a family trust company is prohibited from engaging in pursuant to the FFTC Act. The Limited Liability Company will not offer its services to the general public.

These Articles of Organization shall not be amended without prior written notice to the Florida Office of Financial Regulation.


