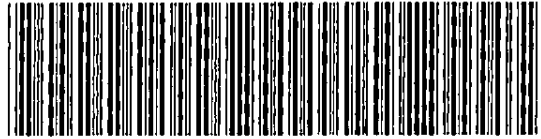

ORGANIZATION OF 2379 SW 9 ST "LLC"**

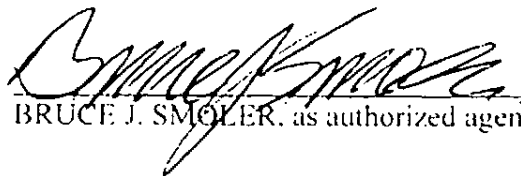
