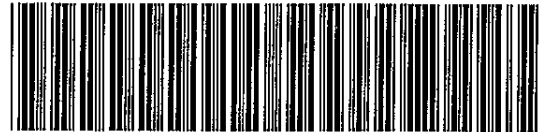

- 1. The name of the corporation is SHAPIRO, BLASI, DECTOR & PIAZZA, P.A. (the "Corporation").
- 2. Article I of the Articles of Incorporation of the Corporation is amended to read as follows:


Article I – Corporate Name
