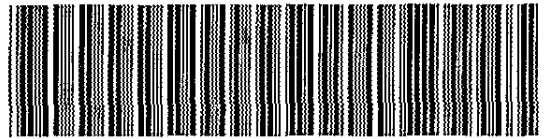

**ARTICLES OF INCORPORATION  
OF  
APPLIED FIBER DEVELOPMENT CORPORATION**

Pursuant to Chapter 607, Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is Applied Fiber Development Corporation.

**ARTICLE II**

This Corporation shall be organized for the purposes of research and development relating to cable products and performing and other related services, and for any other business or purpose which is lawful under the laws of the State of Florida.

**ARTICLE III**

The street address of the principal office of the Corporation is 4082 Forsythe Way, Tallahassee, Florida.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 10,000, par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

**ARTICLE V**

The initial street address of the Corporation's registered office is 215 South Monroe Street, Second Floor, Tallahassee, Florida. The initial registered agent for the Corporation at that address is Kimberly L. King.

**ARTICLE VI**

The initial board of directors shall consist of one (1) member. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one. 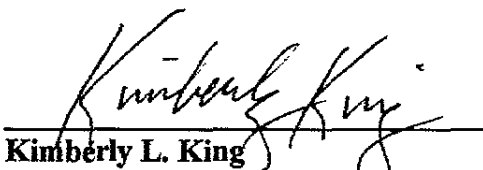
The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
