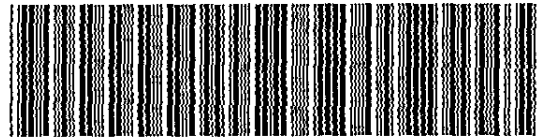

ARTICLES OF ORGANIZATION

F.A.B. Marketing, LLC., a Limited Liability Company

1. **Name.** The name of the limited liability company is **F.A.B. Marketing, Limited Liability Company.**
2. **Purpose.** The purpose of this limited liability company is to engage in sales and marketing of commercial technology and specialty products, including the right to purchase, or otherwise acquire, own, pledge, sell, assign, service, transfer or otherwise dispose of and to invest in, trade in, deal in and with such products and services. The company's business shall include the retention of services of persons in the State of Florida and in all other states and countries; to contract debts and borrow money, and execute such mortgages, transfers of property or other instruments to secure the payment of indebtedness as required; the purpose of the company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.

4. **Term.** Term of this LLC shall be perpetual.
