## ARTICLES OF INCORPORATION SECRETARY 13 AM 10:05 ESSA PROPERTIES, INC.

The undersigned Subscribers, natural persons competent contract, desire to form a Corporation under the laws of the State of Florida, and hereby adopt the following Articles of Incorporation for such Corporation.

#### ARTICLE I. NAME

The name of the Corporation is ESSA PROPERTIES, INC., and the principal office and address is: 6066 ST. AUGUSTINE JACKSONVILLE, FL 32217.

#### ARTICLE II. NATURE OF BUSINESS
