The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

## ARTICLE I -NAME

The name of the corporation shall be A Top-Notch Company, Inc.

## **ARTICLE II - COMMENCEMENT & DURATION**
