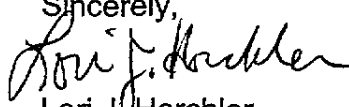

**ARTICLES OF AMENDMENT TO THE CORPORATE CHARTER OF  
ERROL OAKS, UNIT TWO HOMEOWNERS' ASSOCIATION, INCORPORATED**

WHEREAS, the ERROL OAKS, UNIT TWO HOMEOWNERS' ASSOCIATION, INCORPORATED CORPORATE CHARTER (hereinafter "Articles") were executed on the 20<sup>th</sup> day of November, 1978; and

WHEREAS, said Articles may be amended by the approval of at least two-thirds of the membership of the Association voting in person or by proxy at a meeting at which a quorum is present.

NOW, THEREFORE, pursuant to the amendment procedures set forth in said Articles, Article VI of Errol Oaks, Unit Two Homeowners' Association, Incorporated Corporate Charter is hereby amended to read as follows:

**ARTICLE VI**

The business, policies, affairs and funds of the corporation shall be under the control and management of an executive Board of ~~Trustees~~ Directors consisting of not ~~more~~ less than three (3) ~~Trustees~~ Directors, duly elected by the members of the ~~community association~~ Association in accordance with the By-Laws. The number of Directors may be increased or decreased from time to time by resolution adopted by the Board of Directors in accordance with the By-Laws, but no decrease shall have the effect of shortening the term of any incumbent director.

Wherefore, these **ARTICLES OF AMENDMENT TO THE ERROL OAKS, UNIT TWO HOMEOWNERS' ASSOCIATION, INCORPORATED CORPORATE CHARTER** were duly adopted by at least two-thirds of the Membership of the Association voting at a duly called meeting held on the 20<sup>th</sup> day of November, 2002. The number of votes cast by the members was sufficient for approval.
