ARTICLE THREE SHARES

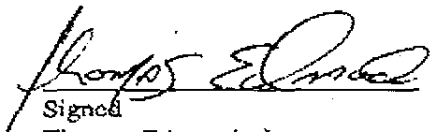

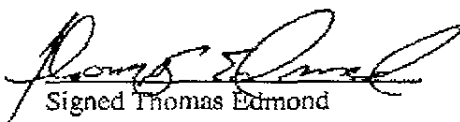

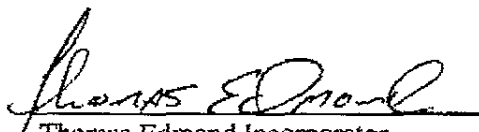
