The undersigned officers of Lands End Condominium Association, Inc. do hereby certify that the following amendments to the Articles of Incorporation of said corporation are a true and correct copy as amended, pursuant to Article IX thereof, by the membership at a duly called and noticed meeting of the members held January 27, 2003 and by the Board of Directors at a duly called and noticed meeting of the Board of Directors held February 6, 2003. The amendments were adopted by the members and the Board of Directors and the number of votes cast for the amendment was sufficient for approval.

AMENDMENTS TO THE ARTICLES OF INCORPORATION OF LANDS END CONDOMINIUM ASSOCIATION, INC.

(Additions shown by "underlining", deletions shown by "strikeout")

ARTICLE II Purpose

2.1 The purpose for which the Association is organized is to provide an entity pursuant to Section 12 of the Condominium Act, which is Chapter 711 718, Florida Statutes 4970, for the operation of the condominium known as and to be known as LANDS END, which condominium is to be located in the Village of North Palm Beach, Florida.

ARTICLE IV Members

4.1 The members of the Association shall consist of all of the record owners of apartments in all of the condominiums established by KING'S REEF, INC., a Florida corporation, and known as LANDS END, and after termination of the condominium shall consist of those who are members at the time of such termination, and their successors and assigns.

ARTICLE V Directors

- 5.1 The affairs of the Association will be managed by a board consisting of net more than nine (9) directors, but in any event-not less than three (3) directors five (5) directors. Directors need net must be members of the Association or the spouse or live-in companion of a member of the Association.
- 5.3 The number of members of the first Board of Directors of the Corporation shall be five (5). The number of members of succeeding Boards of Directors shall be as provided from time to time by the Bylaws of the Corporation. The members of the Board of Directors shall be elected by the members of the Corporation, and at least a majority of

the Beard of Directors shall be members of the Corporation or shall be authorized representatives, officers or employees of a corporate member of the Corporation. Notwithstanding the foregoing, so long as KING'S REEF, INC., a Florida corporation, is the owner of three (3) or more Private Dwellings in LANDS END CONDOMINIUM APARTMENTS, said KING'S REEF, INC. shall have the right to designate and select a majority of the persons who shall serve as members of each Board of Directors of the Corporation; and so long as the said KING'S REEF, INC. is the owner of at least one (1) of the PRIVATE DWELLINGS, the said KING'S REEF, INC. shall have the right to designate and select one (1) of the persons who shall serve as a member of each Board of Directors of the Corporation. The said KING'S REEF, INC. may designate and select the person or persons to serve as a member or members of each said Board of Directors in the manner provided in the Bylaws of the Corporation.

- 5.4 The directors named in these Articles shall serve until the first election of directors, and any vacancies in their number occurring before the first election shall be filled by the remaining directors.
- 5.5 The names and addresses of the members of the first Board of Directors who shall hold office until their successors are elected and have qualified, or until removed, are as follows:
