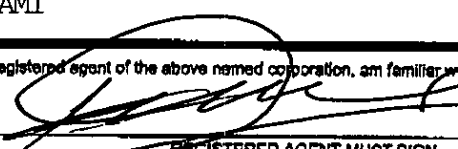

We are hereby submitting a formal report for the reinstatement of the above corporation.

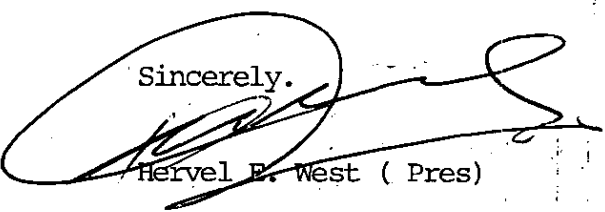
We have not recalled receiving the renewal application needed to file our annual report for the year ending 2002.
