The mailing address and street address of the principal office of the Company is 200 S. Biscayne Boulevard, Suite 4000, Miami, Florida 33131.

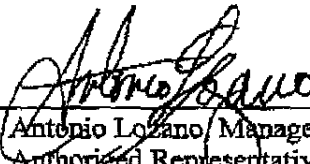
