ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF DENEBA SYSTEMS, INC., A FLORIDA CORPORATION

In accordance with the terms of Section 607.1006 of the Florida Business Corporation Act, **DENEBA SYSTEMS INC.**, a Florida corporation (the "<u>Corporation</u>"), hereby adopts the following amendment to its Articles of Incorporation:

Article IV is hereby amended to read as follows:

ARTICLE IV AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 10,000,000 shares of common stock having a par value \$0.001 per share.
