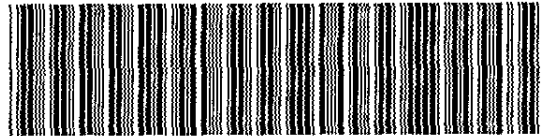

ARTICLE I: NAME

The name of this limited liability company is Approved Florida Title, LLC (hereinafter "Company"), whose principal and mailing address is 4801 S. University Drive, Suite 111, Davie, Florida 33328.

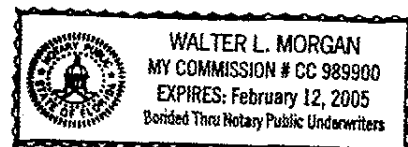
