
This letter concerns annual report fees and statutory penalties which the Department of State is entitled to assess against All American Plumbing LLC under section 608.502(4), Florida Statutes.

An application filed with the Division of Corporations May 12, 2003 indicates All American Plumbing LLC has transacted business in Florida since 2002. Accordingly, an amount of \$1,000.00 is due, reflecting statutory penalties of \$1,000.00. We would, however, offer to settle the issue of foreign non-qualified penalties from All American Plumbing LLC for the sum of \$500.00, reflecting penalties assessed at the statutory minimum of \$500.00 per year. This offer remains in effect until July 31, 2003.

Dear Joey Bryan:

In response to the above-mentioned reference number I would like to tell you why we were late in registering the LLC in the state of Florida.

When we received all the paperwork and instructions for the LLC back in March of 2002 there were no instructions regarding the registration of the LLC in our home state. When I was informed that you must register a corporation in the state you will be doing business in I immediately went to work to get the certificate in good standing along with all of your paper work that is required and sent everything in to you.

It is my understanding that the laws and statutes are to be written so that the average American can understand them and do the paperwork required to comply without having to hire an attorney. (We had an attorney set up the LLC in Nevada and as I stated above he did not instruct us to register in our state.) The laws are not written this way, as we all know.

It was never our intention to ignore any rules or regulations however because of the way the statutes read we failed to understand that foreign meant out of the state and not out of the country. This should be made clear in the statutes. I know you have no control over this but perhaps in the instructions somewhere it could be made known that a foreign corporation means from another state.

Also I would like to inquire as to why the penalty was the highest. This is quite steep for a new company. We haven't even been in business for a full year yet.

You are probably aware that most businesses don't make it and those that do struggle for the first five years. We would like to be in business for a long time here. Please reconsider and wipe out the penalty of \$1000.00. I know I must pay the \$50.00 fee to file for 2002 but I really don't think that it is a good practice to put undue pressure on a new business. The United States needs small businesses to start up and last.

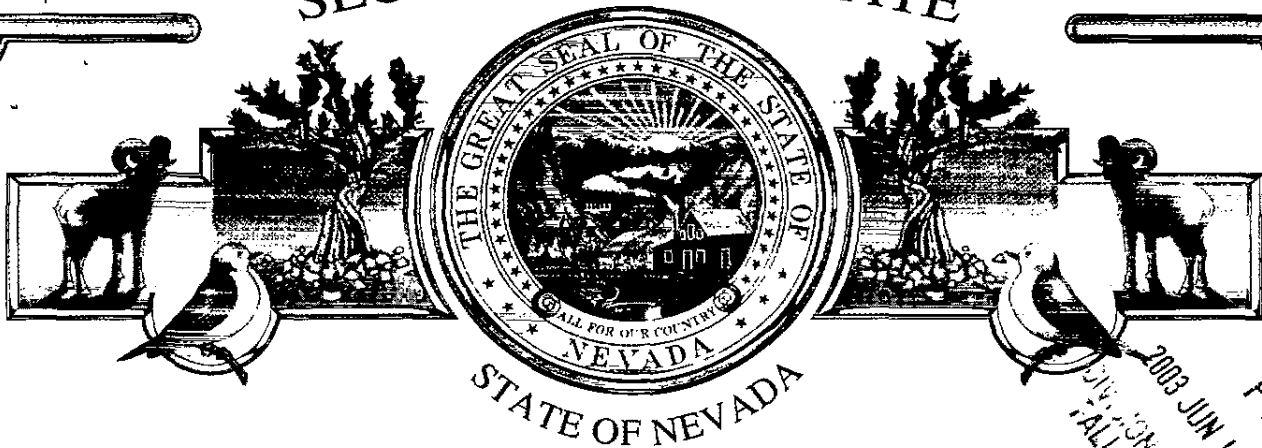
