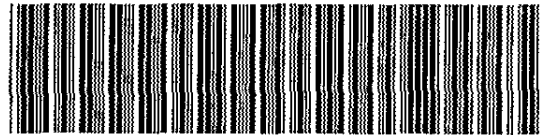


#### ARTICLE VII NATURE OF BUSINESS


The general nature of the business and the objects and purpose to be transacted and carried on are to do any and all the things mentioned, as fully and to the same extent as natural persons might or could do, viz:
