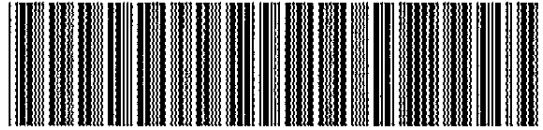

4. There is no other change in the corporation or its membership or in the legal entity that should occur from the enactment of this amendment.






