Thank you for your recent letter/fax requesting approval for use of the above-referenced name to be used within the state of Florida.

Section 655.922, Florida Statutes, exempts a financial institution, holding company or its subsidiaries from the prohibition of using the word "bank," "banker," "banking," "trust company," "savings and loan association," "savings bank," or "credit union" in its corporate name. Therefore, the Office of Financial Institutions will not object to the use of the above-referenced name being registered to transact business as a foreign corporation in this state.

However, this does not give one the authority to act in any lending capacity until all licensing requirements have been met within this state, pursuant to Chapter 494, Florida Statutes, Mortgage Brokerage and Mortgage Lending. Please contact our Bureau of Finance Regulation at 850/410-9500 to determine what licensing requirements may be required.

Also in response to your question of a "suffix" being required with your name, Division of Corporations was contacted and they did indicate a "suffix" was not required.
