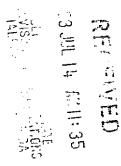

## ARTICLES OF INCORPORATION OF 153 CORP.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

#### ARTICLE II

The existence of the Corporation shall begin on the date of subscription.

#### **ARTICLE III**
