I formed this company, Sonia Co., the end of 2001 and have not done any business so far, but I did not realize that I should have sent in a Business Report even though there was no business activity.

Today, I spoke to a nice gentleman, who told me that a UBR form should have been sent to me also in 2002 for the year 2001 (although I only formed the company on Nov. 14, 2001, only 2 months before the end of that year)

I ONLY GOT 1 UBR form, the one for 2002 (enclosed herewith), and I honestly was not aware that I should file although there was no business done. Please excuse me for this

I am enclosing a check for both years, 2001 and 2003 for \$300.00, and the only UBR form that was sent to me.

I would really appreciate your help in waiving the \$900.00 fee to reinstate my little company.

I am trying very hard to get the business started, but if it does not get going quickly I will have to close it as the fees, and the accountants charges are so high and things are so tough now-a-days. It only gets harder, especially when you are 63 yrs old.....and dont have any money.
