My wife has been supporting our family full time for the last year and we have not had the money

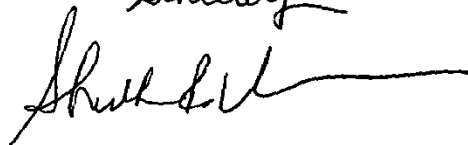
to keep our business active. We would like you
