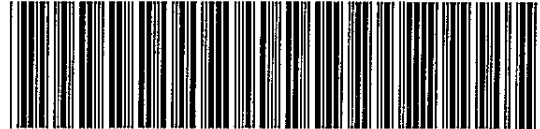

We, the undersigned, as proper persons acting as incorporators of a perpetual corporation under the laws of the State of Florida, adopt the following articles of incorporation:

### **ARTICLE I - NAME**

The name of the corporation shall be: NORRIS EXTERMINATING, INC.

### **ARTICLE II - PRINCIPAL OFFICE**

The principal place of business/mailling address is: 606 B 17<sup>th</sup> Street East, Palmetto, Florida 34221.

### **ARTICLE III - PURPOSE**
