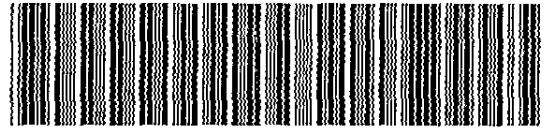

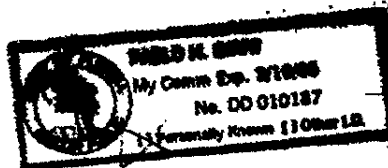
ARTICLE IX - BYLAWS

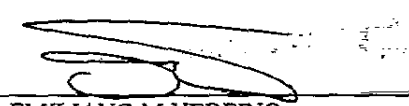

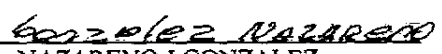
