# ARTICLES OF ORGANIZATION

## SOL COIN LAUNDRY, LLC

The undereigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act. F.S. Chapter 508, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I -- NAME
