ARTICLES OF INCORPORATION OF SANCHEZ MEDIA, INC.

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of this corporation shall be: SANCHEZ MEDIA, INC.



ARTICLE II NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the State of Florida. The general nature of business to be transacted by this corporation is:

- 1. To buy and sell, at wholesale or retail, import and export, design, conceive, invent, and devise all kinds of media, web application, web programs, graphics art, visual art, products, music, and supplies, video or film recording, video or film engineering, video or film productions, creation of video, films, movies, music performance, training videos, all types of entertainment, documentaries, music videos, or broadcast television shows, or television commercials, dvd authoring and duplication, video or film authoring and duplication, clothing, apparel, garment, audio recording, audio engineering, audio leasing, audio productions consisting of writing music, lyrics, scoring, creation of instrumentals, the broadcasting, reception, production or reproduction of sound, music or audio.
- 2. To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer and otherwise dispose of all or any part of its property and assets.
- 3. To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, obligations of, other domestic or foreign corporations, associations, partnerships, or individuals, of direct or indirect obligations of the United States or of any other government, state, territory, government district or municipality or of any instrumentality thereof.
- 4. To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchise and income.

- To conduct its business, carry on its operations, and have offices and exercise the powers granted by the Florida General Corporation Act within or without this state.
- 6. To have and exercise all powers necessary or convenient to effect its purposes, which are allowed or permitted under the laws of the State of Florida.
- 7. The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable or desirable for the furtherance of the corporate objectives expressed above.

ARTICLE III CAPITAL STOCK

The aggregate number of shares of capital stock which the corporation has authority to issue is 2,500 shares, all of which shall be common stock with a par value of \$1.00 per share.

Shares of capital stock in this corporation shall be issued initially to the following persons in the amounts set opposite their names:

ARTICLE IV INITIAL CAPITAL

The amount of capital with which this corporation will begin business in not less than \$250.00.

ARTICLE V

The post office address of the principal office of this corporation shall be 5372 Bosque Lane Unit 132, West Palm Beach, Florida 33415, or at such other place as may hereafter be designated by the Board of Directors. ARTICLE IX CONTRACTUAL POWERS

In the absence of fraud, no contract or other transaction between this corporation and any other person, firm, association, corporation or partnership, shall be affected or invalidated by the fact that any director or officer of this corporation is pecuniarily or otherwise interested in or is a director or officer of any other such firm, association, corporation of partnership, or is a party of pecuniarily or otherwise interested in such contract or other transaction, or is in any way connected with any person, firm, association, corporation or partnership pecuniarily or otherwise interested the existence of a quorum at any meeting of the Board of Directors of this corporation for the purpose of authorizing such contract or transaction with not a director, member or officer of such firm, association, corporation or partnership.

ARTICLE X PRE-EMPTIVE RIGHTS

Each shareholder of the corporation shall be entitled to full pre-emptive rights to acquire his proportional part of any unissued or treasury shares of the corporation, or securities of the corporation convertible into or carrying a right to subscribe to or acquire such shares, which may be issued at any time by the corporation.

ARTICLE XI RESTRICTIONS ON TRANSFER OF STOCK

Shares held by the initial shareholders listed hereinabove may not be resold or otherwise transferred to other persons unless first offered to the remaining shareholders or to this corporation. The price and terms at which, and the time within which those shares may be offered and sold shall be further specified by written agreement among all of the shareholders and this corporation.

ARTICLE XII SPECIAL PROVISO

Any action taken by the directors of this corporation, which is in their power, taken at a meeting of such directors, shall be valid for all intents and purposes whether or not a lawful notice of said meeting shall have be given to all directors as required by law or the Bylaws of this corporation, if at any time prior to, during or subsequent to such meeting, all directors shall have approved the action taken at such meeting.

Any action by the shareholders of this corporation which is within their power, taken at a meeting of such shareholders, shall be valid for all intents and purposes whether or not a lawful notice shall have been given to all shareholders as required by law or the Bylaw of this corporation, if at any time prior to, during or subsequent to such meeting, all shareholders shall execute a waiver of notice and call of such meeting in writing, and providing a majority of the shareholders shall have approved or approve the action taken at such meeting.

Nothing in this Article shall be construed to allow any act by the Board of Directors to be approved by less than a majority of the directors, or whenever a greater vote is required by law or by the Bylaws, buy that vote.

ARTICLE XIII FURTHER POWERS

This corporation shall have the further right and power to, from time to time, determine whether and to what extend and at what times and places, and under what conditions and regulations, the accounts and books of this corporation (other than stock book) or any of them, shall be open to inspection of shareholder, and no shareholder shall have any right to inspect any account, book or document of this corporation, except as conferred by statute, unless authorized by resolution of the shareholders or by the Board of Directors. The corporation may, in its Bylaws, confer powers upon its Board of Directors of officers, in addition to the foregoing and in addition to the powers authorized and expressly conferred by statute.

The shareholders and directors shall have the power, if the Bylaws so provide, to hold their respective meetings and to have one or more offices within or without the State of Florida, and to keep the books of the corporation (subject to the provisions of statute) outside the State of Florida, at such places as may from time to time be designed by the Board of Directors.

The corporation reserves the right to amend, alter, change, or repeal any provisions contained in these Article of Incorporation, in the manner now or hereafter prescribed by statute, and all rights conferred upon shareholders herein are granted subject to this reservation.
