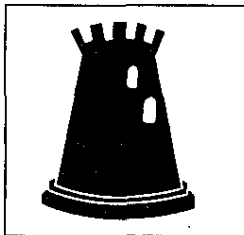

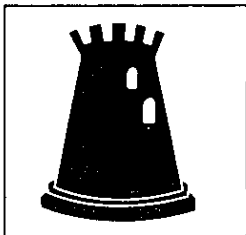
Pat Bailey,
