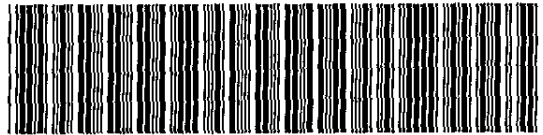

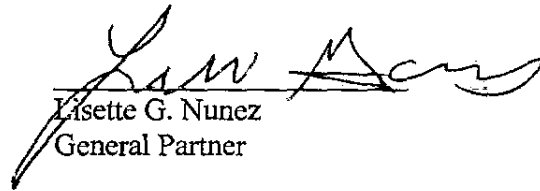

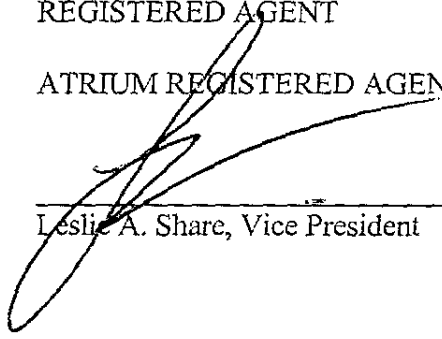
**ACCEPTANCE OF APPOINTMENT AS REGISTERED AGENT**

**AFFIDAVIT OF CAPITAL CONTRIBUTIONS**

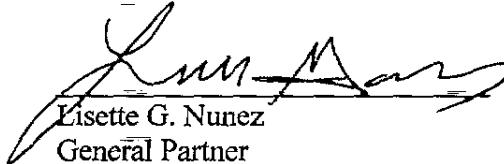
