Also, as discussed we have funds immediately available at escrow to close on a helicopter transaction.

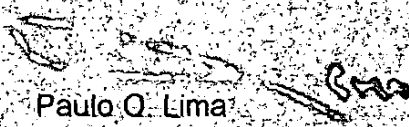
