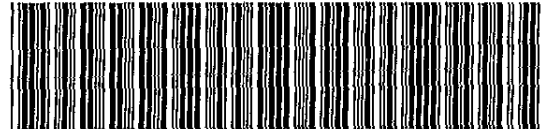

The principal place of business and mailing address of the association are the same and is: 4312 El Prado Blvd., Tampa, Florida 33629


ARTICLE IV. PURPOSE.


ARTICLE VII. STOCK ASSOCIATION.
