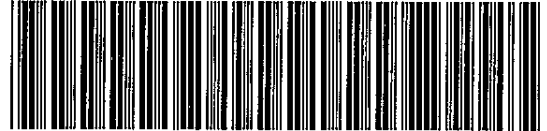

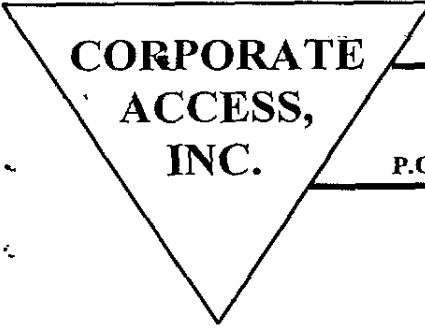

ARTICLE 1


The name of the corporation is **Bates Driscoll Construction, Inc.**


