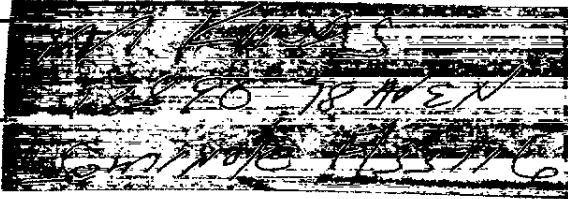

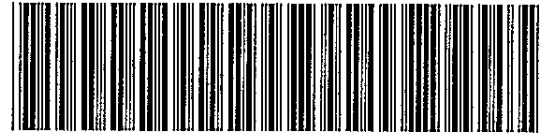

ARTICLES OF INCORPORATION

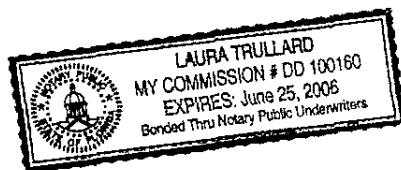


